Important Information about giftaid

How do I know if I am eligible to request Gift Aid to be recovered on my donations?

In order for Gift Aid to be recovered on your donations you must pay an amount of income tax and/or capital gains tax at least equal to the tax that all the charities and/or community amateur sports clubs you donate to will reclaim on your donations in the tax year (currently 25p for each £1 that you give.)

If you are unsure whether your donations qualify for Gift Aid tax relief, read the notes provided with this pack and consult a tax adviser if still unclear.

What should I do if I no longer pay enough tax?

If your circumstances change and you no longer pay tax on your income and capital gains tax equal to the tax the charity reclaims, you can cancel your declaration.

How can I cancel my Gift Aid declaration?

You can cancel your declaration at any time by notifying the charity. Gift Aid will then not apply to donations you make on or after the cancellation date or such later date as you specify.

What should I do if I pay tax at the higher rate?

If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self Assessment tax return or ask HMRC to adjust your tax code.

What should I do if any of my details change?

If your declaration covers donations you make in the future please notify the charity if you change your name and/or address while the declaration is still in force.

Rebuilding and Restoration

We are in the process of rebuilding and restoration. We need to rebuild our church family as we meet together again. We need to re-examine our vision and how that translates to a post-Covid world. We need to rebuild the ways in which we serve.

Part of this rebuilding involves our church finances, which have been hit hard during Covid. We are asking you to prayerfully consider the part that you can play. We recognise that there are significant pressures, with the cost of living increasing. But Jesus urges us not to be anxious, but to trust God for what we need. Giving is always an act of faith and lived out generosity is the way of Christ.

As a church, God blessed us with a substantial gift in 2020, and we know that many of you give generously and consistently, but we now have a deficit budget as giving has decreased whilst costs have increased.

How does our giving enable vital ministry

There is an urgent need in Ferndown for the Good News to be clearly proclaimed! We need to grow our work with children and families. We need to share the hope of Jesus at a time when many are anxious and afraid. Over this past year we have reached out with His love through our many groups and activities, including Open Doors, Little Sheep, Life Groups, Youthwork, Alpha, the Wellbeing Journey and through the ministry of the Café to name a few. We have put our services online and increased our social media presence reaching those unable to be with us in person. We have served local people in baptisms, weddings and funerals and ministered to the sick and bereaved. We have seen people healed, set free and find faith! This is not a time to pull back! All this is possible because the people His goodness, and want to see His Kingdom come and His will done.

In terms of how much we should give, the Bible gives tithing to church as the baseline – this is the first 10% of our income. Giving is to be a cheerful expression of our love and worship.
